Updated Resolution Regarding District Service Fees

- The Board of Directors voted to approve an updated District Service Fee Resolution at the November 22nd, 2022, Meeting.

- Exhibit B to the Resolution outlines the Fee Schedule. The General Operations Fee for Single Family and Attached Family homes increases annually by the Consumer Pricing Index as authorized by the Resolution.
- The 2021 increase was added to the Q1 2023 invoice adding an additional \$1.25 per quarter.
- The 2022 increase will be added to the Q2 2023 invoice adding an additional \$16.33 per quarter.
